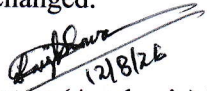
In partial modification of Notification no. DU/DR-A/3rd & Higher Sem.Admission/2026/679 dated: 23-07-2026, and in pursuance of the Corrigendum published vide memo no. E-413540/2026/223 dated: 10-08-2026 by the Govt. of Assam, this is for information of all concerned that, students having arrears/backlogs in the previous academic year(s) shall also be eligible to avail the benefit of the Fee Waiver Scheme, subject to the condition that only 50% (fifty percent) of the applicable fees shall be waived in respect of such students. The remaining 50% (fifty percent) of the applicable fees shall be payable by the concerned students. Accordingly, the admission schedule for the students of 3rd and higher semesters is revised as stated hereunder-

25 th August, 2026 (11:59 p.m.)	Last date of submission of fees without fine
31 st August, 2026 (11:59 p.m.)	Last date of submission of fees with fine

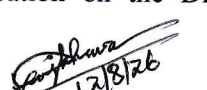

**Standard Operating Procedure (SOP) for availing Fee Waiver
under Pragyan Bharati Scheme of Govt. of Assam
for the session 2026-27**

The students intending to avail the fee waiver benefit (free admission) **for admission into 3rd and Higher Semester (Odd Semester) Classes of all the Under Graduate, Post Graduate and Integrated academic programmes of Dibrugarh University campus** in pursuance of the Memo no: 413540/2026/204-A dated:- 04-07-2026, need to submit the following documents to the Head of the Department concerned on or before 14th August, 2026 –

- i) Ration card/Income Certificate (latest)
- ii) An undertaking in the prescribed format (Annexure – II)
- iii) ADHAAR details along with consent letter (Annexure – III)

Important Points to be noted by the students intending to avail Fee Waiver:-

1. All the enrolled students shall primarily get the payment link in their Student Portal (ERP) with full fee. However, they need not pay their fee until 21-08-2026 i.e. till their documents get verified.
2. Students intending to avail Fee Waiver should ensure that, their Fee Waiver receipt is generated in their Student Portal (ERP) by 25-08-2026. However, students having backlog in previous academic sessions need to ensure their payment of 50% fee as per the admission schedule stated above. If, no payment link is seen in the ERP login by the students, they need to report the same to the Dibrugarh University Cash Counter.
3. If a student intending to avail Fee Waiver does not get the Fee Waiver receipt in their Student Portal (ERP) until 25-08-2026, they are required to report immediately to the **Dibrugarh University Cash Counter**. In case, if the student does not get the Fee Waiver receipt within due course of time, then it might affect their examination form fill-up process.

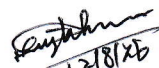
Role of the Head of the Departments (HoDs) :-

- a) The HoDs shall consider to receive the aforesaid documents till 14th August, 2026.
- b) After receipt of the documents within stipulated time, the HoDs or their authorized representative shall list out the names of all the applicants and shall certify in the prescribed format (**Annexure – IV**) that, the student has fulfilled the following criterions in addition to the submission of aforesaid documents –
 - i. Attendance of the student during the last semester must not be less than 70%.
- c) Upon being satisfied about the student's eligibility under Fee Waiver Scheme, the HoD shall affix the "**Fee Waived**" Seal on the reverse side of the last examination marksheet of the intending student. However, clear note should be given on the reverse side in case of a student availing fee waiver but is having backlogs in previous years.
- d) After completing the above steps, the documents need to be submitted to the Dy. Registrar (Academic), Dibrugarh University on or before 21-08-2026, for necessary updates in the SAMARTH portal and for creating centralized database (Please refer the list of documents to be submitted).
