**ADMISSION NOTICE**

**Five Year Integrated B.A.LL.B.(Honours)Programme  
SESSION: 2026-2027 for Centre For Juridical Studies  
(With Up to date BCI Approval)  
Dibrugarh University**

Online applications are invited from the Eligible Candidates for admission into the **Five-Year Integrated BALLB(Honours)** Programme for the Academic Session 2026-27 from the candidates whose score are published in the Merit List of the Common Admission Test (CAT) for admission into Five Year Integrated BA/BBALLB(Honours)/BBALLB (Non-Honours) Programme for Academic Session 2026-2027, **held on 28<sup>th</sup> June 2026 as per notification No DU/DR-1/4-1/2026/CAT/5039, dated: 08/05/2026** subsequent modification /Extension. The candidates intending to apply for admission to the Centre for Juridical Studies, Dibrugarh University shall fill up the online application form which will be available in the Dibrugarh University Website. [www.dibru.ac.in](http://www.dibru.ac.in) from **11<sup>th</sup> July 2026 and shall remain open till midnight of 20<sup>th</sup> July 2026 (Up to 11.55 pm).**

**Eligibility for Admission:** A candidate for admission to the Five-year BALLB(H) Course should have passed the Higher Secondary Examination (10+2) or an equivalent examination securing at least 45% in aggregate of the total marks.

*(Any other issue of eligibility shall be decided as per BCI and University Rules as may be necessary )*

**Admission Procedure:**

The admission to the aforesaid Programme will **be allowed only on Merit basis through Common Admission Test (CAT)-2026 held on 28<sup>th</sup> June 2026** for admission into Five Year Integrated BA/BBALLB(Honours)/BBALLB(Non Honours) Programme for Academic Session 2026-2027 conducted by the University. On being selected for admission at the Centre for Juridical Studies, the applicant shall appear before Admission Committee at the Centre for Juridical Studies, Dibrugarh University with all original certificates, mark sheets and other requirements on scheduled date and time. If any selected candidate fails to deposit prescribed admission fee with required documents within the stipulated time, his/her admission shall automatically stand cancelled.

***If any selected candidate does not appear before Admission Committee on scheduled date and time, his/her candidature shall be deemed to be cancelled without any intimation in writing.***

**Total intake : 60 seats including (04) endowment category seats**

**Reservation of seats under Categories**

**1) Statutory Reservation:**

Scheduled Caste	(S.C.)	7%
Scheduled Tribes, Plains	(S.T.P.)	10%
Schedule Tribes, Hills	(S.T.H.)	5%
Backward Classes	(O.B.C./M.O.B.C) Non Creamy Layer	27%

**Note:**

- I. Caste Certificate must be issued by the competent authorities and countersigned by the Deputy Commissioner of the District Concerned or competent officer.
- II. Candidates seeking admission under the category of OBC/MOBC must produce the **latest non-creamy layer valid certificate from the concerned Circle Officer if the parents/guardians of candidates are agriculturalists. Other candidates belonging to the category shall produce the latest non creamy layer certificate from the competent District Authority as per Rules.**

**2) Reservation of seats on other ground:**

- I. **10% seats for Economically Weaker Sections (EWS)** are created are on supernumerary basis as per norms and rules in force and will be admitted on the basis of merit.
- II. 5% seats are reserved of the total intake for Differently-abled category and Bonafide certificate shall be required for claiming the reservation for the Joint Director of Health Services and **duly verified by the Senior Medical Officer of Dibrugarh University**
- III. 01 (one) seat is reserved for son and daughter of Dibrugarh University Employees as per University Policy.
- IV. **The candidates intending to take admission under the Endowment category having (04) four seats shall submit offline applications recording score of the CAT 2026 on 28<sup>th</sup> July 2026 after close of the admission and hence are advised to remain present at the admission venue and no claim shall be entertained subsequently.** The Application Format shall be provided by the Centre for Juridical Studies.

## **Application Procedure**

- a) Online Application process will start from **11<sup>th</sup> July,2026**. Application for admission to the academic Programme shall be through online mode only. No other means of application shall be accepted.  
The last date for submission of application is **20<sup>th</sup> July 2026(up to 11.55 pm)**
- b) For submission of the **Online Application**, intending candidates are advised to follow the following instructions:
- I) **The candidate shall be required to login to the Application Submission Portal given on the website www.dibru.ac.in through the same mobile number and password used while applying for the Common Admission Test for admission into Five Year Integrated BA/BBA.LLB (Honours)/BBA.LLB(Non-Honours) Programme for Academic Session( 2026-2027).**
  - II) **After login, the candidate needs to click on the “Apply” button corresponding to the link of “Five Year Integrated B. A. LL. B. (Honours) which will lead to an application form. The candidate needs to fill up the application form step by step.**
  - III) **After filling-up the Form completely the candidate needs to click the button “Submit and Review”. A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit.**
  - IV) **After ensuring that all the information displayed on the Preview is correct, the candidate needs to click ‘Pay now & Submit the application” and pay the application fee of Rs 950/- (Nine Hundred Fifty) only through online mode (Debit Card/Credit Card/Internet Banking).**
  - V) **The application form will be considered as finally submitted only when the application fee is successfully paid by the candidate and an online receipt is generated confirming the payment. After final submission, no editing of the application form is permitted from the candidate’s end.**
  - VI) **There will be a button to download Application Form for future reference of the concerned candidate.**
  - VII) **The Submission of Online Applications shall be automatically closed after the stipulated time.**
  - VIII) **No individual letter will be issued and sent to the candidates on any matter(s) of admission process. Candidates shall visit the University website www.dibru.ac.in frequently for any relevant information.**
  - IX) **No claim shall be entertained if application is filled after due time, as per the notification.**

Other candidates belonging to the category shall produce the latest Non Creamy Layer certificate from the competent District Authority as per Rules.**
- Latest E.W.S. Certificate from the Competent Authority, where necessary
- For Differently-abled candidates , medical certificate issued by the Joint Director of Health Services of the district concerned and being countersigned on verification by the Senior Medical Officer , Dibrugarh University
- Certificate from the Registrar of Dibrugarh University for category of sons and daughter of Dibrugarh University Employees /Retired Employees.
- A set of self-attested testimonials photocopied from the original.
- **Affidavit regarding NO RAGGING as per the format annexed as ( Annexure I & II). This is mandatory and there shall be no relaxation**
- **Declaration containing guardian's contact no, email and undertaking that payment of fees including hostel fees (where necessary) shall be done regularly.**

- **One Time Endowment fees Rs. 35,000 (Thirty Five Thousand) for Endowment Category applicants (04 SEATS) only in addition to Admission fees for first Semester.**
