- viii) The Admission Fee, Course Fee, etc. shall have to be paid at the time of admission (***Please refer the Information Brochure of Five year Integrated Postgraduate Programme (FYIPGP) available on the Dibrugarh University website and Annexure A, B & C***)
- ix) The Admission Fee, Course Fee, etc. (wherever applicable) to be paid by the candidates at the time of admission through online mode by using their Debit Card/ Credit Card or internet banking/UPI.
- x) **The Admission of the candidates shall be held in the respective Departments / Centre of Dibrugarh University on the scheduled dates only** (***Please refer the notification issued by the Directorate of Higher Education vide no. 775718/10, dated 06.05.2026***)
- xi) The Selection and Admission to all the Academic Programmes covered by this Notification shall be purely provisional and subject to fulfillment of requisite norms of Qualifying Examinations and other relevant criteria.

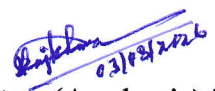
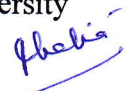
Instructions to the candidate: -

1. The **Candidate must keep handy**, duly sealed and signed **original admission confirmation slip**, the e-Samarth application number/form, registered phone number for online transaction, valid Debit Card/Credit Card in order to avoid last minute rush.

2. The candidate intending to pay using Debit Card/Credit Card must ensure that, adequate **limit is provided by their host banks**. If adequate limit is not available on the card, the candidate is advised to do the same by following the instructions provided on the respective bank's website. The process of enhancing limit differs from one bank to the other.
3. The candidate must ensure that, **e-commerce transaction is allowed** on their Debit Card by the respective host banks.
4. The candidates will pay the admission fee at **Digital lounge payment facilitation centre**, ground floor, Indira Miri Conference Hall, behind LNB Library.
5. The candidate will be allowed to use any one of the modes of payment stated above. One mode of payment cannot be mixed with the other i.e. **the modes of payment are mutually exclusive**.

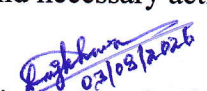

PROGRAMME (FYIPGP) UNDER NON-CUET CATEGORY FOR THE 2026-2027
SESSION**

Annexure F

For spot admission to the Five-Year Integrated Post Graduate Programme (FYIPGP) of Dibrugarh University under Non-CUET Category, the following procedure shall be followed:

- i. Dibrugarh University shall notify the date and reporting time for spot admission as per the guidelines received from the Higher Education Department, Assam.
- ii. The intending candidates shall have to apply for spot admission through the Samarth portal and report to the concerned Department of the University strictly on or before the reporting time with all the original documents.
- iii. After expiry of the reporting time, no new candidate shall be allowed for that day.
- iv. Candidates who reach the spot (concerned Department of the University) on or before the reporting time shall be eligible for consideration for selection against the vacant seats under different categories and the selection will be done on the basis of the Merit Score (i.e. Aggregate percentage in Best Five (05) subjects in 10+2 Examination) for each vacant category subject to the fulfilment of basic eligibility criteria and submission of all the requisite documents.
- v. In case of two or more candidates securing an equal percentage of marks in 10+2 examination, merit shall be determined based on aggregate percentage in class 10 examination.
- vi. Candidates are advised to refer the Guidelines for Spot Admission 2026 issued by the Higher Education Department, Govt. of Assam (available at <https://assamadmission.samarth.ac.in/>)
- vii. For any matter not covered by the above clauses, the decision of the Competent Authority shall be final and binding.
