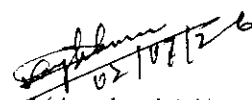

The attention of all the scholars are drawn to the following:

1. The scholar has to pay Ph.D. registration fee of Rs. 6000/- (*Rupees Six thousand*) **within one month from** the date of issue of this Notification, failing which the permission for registration will stand automatically cancelled.
2. The registered Ph.D. Scholars under Faculty of Science and Engineering, Faculty of Earth Sciences and Energy, Faculty of Biological Sciences shall have to pay Rs. 400/- (Rupees Four hundred) only per month from the month of effect of his/her Ph.D. Registration till the month of submission of his/her thesis.
3. The registered Ph.D. Scholars under Faculty of Humanities and Law, Faculty of Social Sciences, Faculty of Commerce and Management Science and Faculty of Education shall have to pay Rs. 300/- (Rupees Three Hundred) only per month from the month of effect of his/her Ph.D. Registration till the month of submission of his/her thesis.

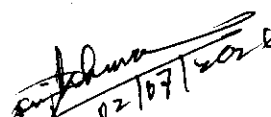
4. If any registered Ph.D. Scholar fails to pay the monthly fee at least once in every six months, his/her admission for Ph. D Programme may stand cancelled.
5. **All payments by the Ph.D. Scholars to be made online through ERP Portal only. Payment through any other mode shall not be accepted.**
6. The registered Ph.D. Scholar shall have to submit the **Registration Fee acknowledgement receipt** along with the Photocopy of the Dibrugarh University **Registration Card/Certificate** at the Office of the Deputy Registrar (Academic), Dibrugarh University within one month from the date of issue of this Notification.
