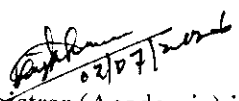

3. If any registered Ph.D. Scholar fails to pay the monthly fee at least once in every six months, his/her admission for Ph. D Programme may stand cancelled.
4. **All payments by the Ph.D. Scholars to be made online through ERP Portal only. Payment through any other mode shall not be accepted.**
5. The registered Ph.D. Scholar shall have to submit the **Registration Fee acknowledgement receipt** along with the Photocopy of the Dibrugarh University **Registration Card/Certificate** at the Office of the Deputy Registrar (Academic), Dibrugarh University within one month from the date of issue of this Notification.
